RESCINDING ADMINISTRATIVE ORDERS  
A-2013-54 and A-2015-61**

**WHEREAS**, in order to provide effective coordination of professionalism programs and activities throughout the Fifth Judicial Circuit and in accordance with the Florida Supreme Court's Administrative Order entitled In Re: Commission on Professionalism, dated June 11, 1998, mandating the establishment of a local Professionalism Committee in each judicial circuit; and

**WHEREAS**, in the interest of promoting professionalism, a Professionalism Committee allows the bench and the Bar to coordinate professional activities for lawyers and judges in furtherance of and in an effort to maintain the highest standards of professionalism in the Fifth Circuit, this Fifth Judicial Circuit has established the **Fifth Judicial Circuit Professionalism Committee, Educational Division**; and

**WHEREAS**, on June 6, 2013, the Florida Supreme Court entered Administrative Order No.:SC13-688 In Re: Code For Resolving Professionalism Complaints; and


**WHEREAS**, said Order mandates that a local subdivision of the Fifth Circuit Professionalism Committee be developed in each County in this Fifth Circuit to receive, screen and act upon any and all complaints of unprofessional conduct and to resolve those complaints informally, if possible, or refer to The Florida Bar if necessary, this Fifth Judicial Circuit has established the **Fifth Judicial Circuit Professionalism Committee, Professionalism Practice Division**; and, therefore,

As Chief Judge of this Fifth Judicial Circuit and in accordance with Florida Rule of Judicial Administration 2.215(b)(2), it is now:

**ORDERED:** That

1. The **HONORABLE S.SUE ROBBINS**, Circuit Judge in and for Marion County, is hereby appointed as **Chair of the Fifth Judicial Circuit Professionalism Committee, Educational Division**.
2. The **HONORABLE ANN MELINDA CRAGGS**, Circuit Judge in and for Marion County, is hereby appointed as **Chair of the Fifth Judicial Circuit Professionalism Committee, Professional Practice Division**.
3. **Administrative Orders A-2013-54 and A-2015-61 are hereby RESCINDED.**
