

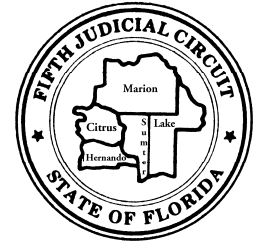

“MHC Milestone Meeting”

In 2011, Marion County was awarded an implementation grant specifically to create and operate a Mental Health Court to increase public safety, avert increased spending in criminal justice, and improve the accessibility and effectiveness of treatment services for adults who have a mental illness, substance abuse disorder or co-occurring mental health and substance abuse disorders and who are in, or at risk of entering, the criminal justice system in Marion County. The efforts behind this “Milestone 3 & 4” meeting are to provide a report on our achievements for our third and final year as this grant concludes at the end of February. This will be our “wrap-up” meeting.

The Management Team for the Criminal Justice, Mental Health and Substance Abuse (CJMHS) Reinvestment Implementation Grant invites the media, representatives and members of the public to attend the consolidated “Milestone 3&4” meeting to learn about the outcomes of the Marion County Mental Health Court implementation grant and the future growth and sustainability of our county’s Mental Health Court program.
