**ADMINISTRATIVE ORDER APPOINTING THE HONORABLE JIM MCCUNE

ALTERNATE CHAIR OF THE MARION COUNTY 2019-2020 CANVASSING
BOARD AND VACATING THE FOLLOWING ADMINISTRATIVE ORDERS:

WHEREAS, the Chief Judge of the Fifth Judicial Circuit has the responsibility, pursuant to Fla. Stat. § 102.141, to appoint a County Court Judge as the Chair of the Marion County Canvassing Board; and

WHEREAS, the Chief Judge of the Fifth Judicial Circuit is empowered, pursuant to Fla. Stat. § 102.141, to appoint an alternate judicial member of the Marion County Canvassing Board; and

WHEREAS, such alternate judicial member is required to be a County Court Judge, qualified to serve, if available; and

WHEREAS, the **HONORABLE JIM MCCUNE**, County Court Judge, is a qualified elector of the county who is not a candidate with opposition in the election being canvassed and who is not an active participant in the campaign or candidacy of any candidate with opposition in the election being canvassed;

WHEREAS, the **HONORABLE SARAH RITTERHOFF-WILLIAMS**, County Court Judge, is a qualified elector of the county who is not a candidate with opposition in the election being canvassed and who is not an active participant in the campaign or candidacy of any candidate with opposition in the election being canvassed;

It is therefore **ORDERED AND ADJUDGED** that the **HONORABLE JIM MCCUNE**, Marion County Court Judge is hereby appointed to serve as a member and Chair of the Marion


