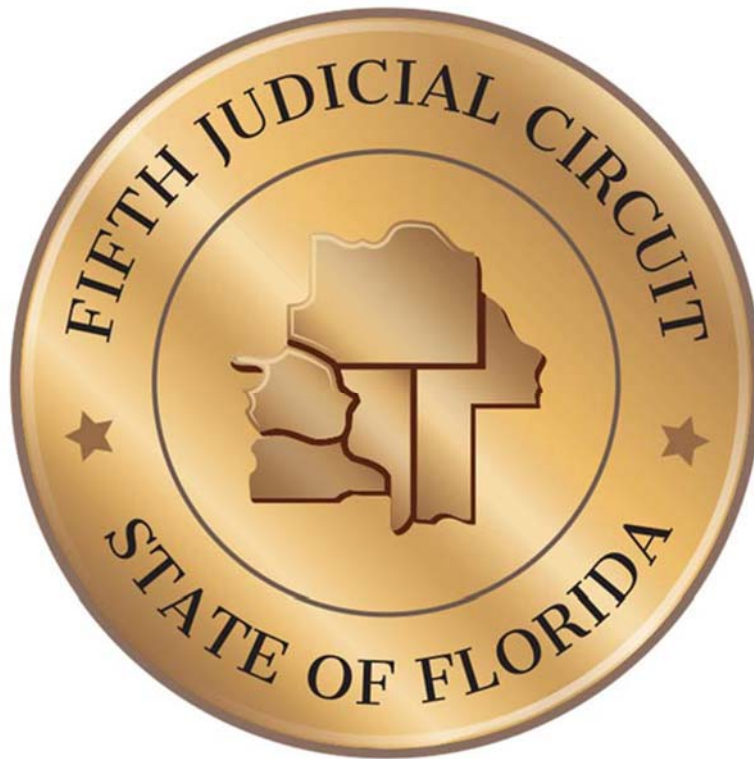


COURT APPOINTED EXPERT WITNESS FOR CRIMINAL AND JUVENILE DELINQUENCY CASES
