

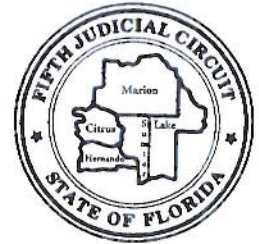

### HERNANDO COUNTY October 22, 2012

Judge Daniel B. Merritt, Sr. handed down the sentence today in *The State of Florida v. Sherrie Ann Dicus*. Defendant Dicus entered into a plea agreement on September 16, 2012. Her sentence is as follows:

- Count 1. For the plea of guilty of murder in the second degree, in the death of Enrique Daniel Acevedo; the defendant is sentenced to life in the Florida Department of Corrections.
- Count 2. For the plea of guilty in the attempted felony murder for the attempted murder of Skyler Nicole Collins; the defendant is sentenced to life in the Florida Department of Corrections.
- Count 3. For the plea of guilty, carjacking while armed; the defendant is sentenced to 30 years in the Florida Department of Corrections.
- Count 4. For the plea of guilty, robbery with a deadly weapon; the defendant is sentenced to 30 years in the Florida Department of Corrections.

The sentences in all four counts are to run concurrently.

Dicus was charged along with codefendants Steven Allen Wesolek and Sabrina Marie Dicus for these crimes. Wesolek was sentenced on May 16, 2012 to life without the possibility of parole. Sabrina Marie Dicus entered a plea of guilty on September 22, 2011. Sabrina Dicus sentencing hearing was not to be held until after the trial of the two codefendants, her sentencing is scheduled for later today.

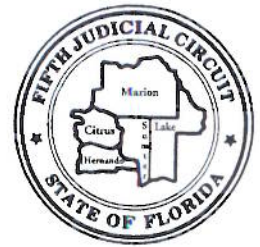

### **HERNANDO COUNTY** **October 22, 2012**

Judge Daniel B. Merritt, Sr. handed down the sentence today in *The State of Florida v. Sabrina Marie Dicus*. Defendant Dicus entered into a plea agreement on September 22, 2011. Her sentence is as follows:

- Count 1.** For the plea of guilty of murder in the second degree, in the death of Enrique Daniel Acevedo; the defendant is sentenced to ten years in the Florida Department of Corrections, followed by ten years of probation.
- Count 2.** For the plea of guilty in the attempted felony murder for the attempted murder of Skyler Nicolle Collins; the defendant is sentenced to 10 years in the Florida Department of Corrections, followed by 10 years of probation.
- Count 3.** For the plea of guilty of carjacking while armed; the defendant is sentenced to 5 years in the Florida Department of Corrections, followed by 15 years of probation.
- Count 4.** For the plea of guilty, robbery with a deadly weapon; the defendant is sentenced to 5 years in the Florida Department of Corrections, followed by 10 years of probation.
- Count 5.** For the plea of guilty of home invasion robbery; the defendant is sentenced to 5 years in the Florida Department of Corrections, followed by 10 years of probation.

The sentences in all five counts are to run concurrently.

Dicus was charged along with codefendants Steven Allen Wesolek and Sherrie Anne Dicus for these crimes. Wesolek was sentenced on May 16, 2012 to life without the possibility of parole. Sherrie Anne Dicus was sentenced to life earlier today.
