the offense occurs, the arrest is made, or the warrant is issued; and

establish a bond amount in connection with arrest,

In consideration thereof and in accordance with Florida Rule of Judicial Administration

2.215, it is

ORDERED

1. The attached Bail Schedule shall continue to be the official Bail Schedule for the

Fifth Judicial Circuit.

2. Administrative Order A-2014-12 is hereby superseded and amended.

3. The attached Bail Schedule was first approved by A-2014-12 on May 16, 2014, and

remains unchanged.
