WHEREAS, the Board of County Commissioners have named an alternate to the Chair of the Board of County Commissioners, pursuant to Florida Statutes § 102.141; and

WHEREAS, WAYNE DUKES, is a qualified elector of the county who is not a candidate with opposition in the election being canvassed and who is not an active participant in the campaign or candidacy of any candidate with opposition in the election being canvassed; and

It is therefore **ORDERED AND ADJUDGED** that the **HONORABLE KURT E. HITZEMANN** Hernando County Court Judge is hereby appointed to serve as Chair of the Hernando County Canvassing Board for the 2020 election cycle.

It is further **ORDERED AND ADJUDGED** that the **HONORABLE KRISTIE HEALIS**, is hereby appointed to serve as the alternate judicial member of the Hernando County Canvassing Board for the 2020 election cycle.

It is further **ORDERED AND ADJUDGED** that the **HONORABLE DONALD E. SCAGLIONE**, Circuit Judge, is hereby appointed to serve as the alternate to the Supervisor of Elections, Shirley Anderson, on the Hernando County Canvassing Board for the 2020 election cycle.
