**WHEREAS**, the Chief Judge of the Fifth Judicial Circuit has the responsibility, pursuant to Section 102.141(1), Florida Statutes, to appoint a county court judge as the chair of the Marion County Canvassing Board; and,

**WHEREAS**, Section 102.141(1)(e)1., Florida Statutes, requires the Chief Judge of the Fifth Judicial Circuit to appoint a Marion County court judge as an alternate member of the Marion County Canvassing Board, if said judge is able and not disqualified to serve; and,

**WHEREAS**, the **HONORABLE JAMES MCCUNE**, Marion County Court Judge, is a qualified elector of Marion County who is not a candidate with opposition in the election being canvassed and

who is not an active participant in the campaign or candidacy of any candidate with opposition in the election being canvassed; and,

**WHEREAS**, the **HONORABLE ROBERT E. LANDT**, Marion County Court Judge, is a qualified elector of Marion County who is not a candidate with opposition in the election being canvassed and who is not an active participant in the campaign or candidacy of any candidate with opposition in the election being canvassed;

It is therefore **ORDERED AND ADJUDGED** that the **HONORABLE JAMES MCCUNE**, Marion County Court Judge, is hereby appointed to serve as a member and Chair of the Marion County Canvassing Board for the 2021 – 2022 election cycle.


It is further **ORDERED AND ADJUDGED** that the **HONORABLE ROBERT E. LANDT**, Marion County Court Judge, is hereby appointed to serve as the alternate judicial member of the Marion County Canvassing Board for the 2021-2022 election cycle.
