## ADMINISTRATIVE ORDER REGARDING TEMPORARY APPOINTMENT OF CHARLES HELM AS CIRCUIT JUDGE

(amended only to properly name the Honorable S. Sue Robbins)

WHEREAS, Article V, section 2(d) of the Florida Constitution and section 43.26, Florida Statutes, charges the chief judge with the authority to promote the prompt and efficient administration of justice in the courts over which he or she is chief judge; and,

WHEREAS, the Florida Supreme Court, pursuant to Rule 2.215(5) of the Florida Rules of Judicial Administration permits the Chief Judge to designate a judge in any court or court division as an Administrative Judge; and,

WHEREAS, the undersigned, the Honorable Carol A. Falvey, has been designated by the Chief Judge as Administrative Judge for Citrus County, pursuant to Rule 2.215(b)(5), Florida Rules of General Practice and Judicial Administration; and,

WHEREAS, the Florida Supreme Court, pursuant to Rule 2.215(b)(4) of the Florida Rules of General Practice and Judicial Administration, authorizes a chief judge to assign any judge to temporary service for which the judge is qualified in any county in the same circuit; and,

WHEREAS, the retirement of the Honorable S. Sue Robbins, as Circuit Court Judge in Marion County, has necessitated the usage of judicial resources outside of Marion County to assist in the coverage of the delinquency and dependency docket of Marion County until a new judge is appointed; and,

WHEREAS, the Honorable Stacy M. Youmans, who is deemed qualified to hear any delinquency and dependency matters, and having consented to the temporary assignment to preside over delinquency and dependency dockets in Marion County on Mondays, beginning November 1, 2021; and,

WHEREAS, the Honorable Charles Helm, who is deemed qualified to act as Circuit Judge to hear matters on a temporary basis, and having consented to the temporary assignment; and

WHEREAS, it is deemed necessary and appropriate for the prompt, effective, and efficient administration of justice within the courts of the Fifth Judicial Circuit, and in order to maintain judicial integrity, and with the advice and consent of the Chief Judge for the Fifth Judicial Circuit;

## It is **THEREFORE**

## **ORDERED AND ADJUDGED** as follows:

- 1. The Honorable Charles Helm is appointed to serve as Circuit Court Judge beginning and including Monday, November 1, 2021, and continuing each Monday thereafter.
- 2. The Honorable Charles Helm is to assume the duties of the Honorable Stacy M. Youmans in Citrus County, Florida on Mondays, beginning November 1, 2021.
- 3. This Administrative Order shall take effect to include Monday, November 1, 2021, and shall remain in full force and effect until further order of the undersigned.
