ORDER DISMISSING PETITION FOR WRIT OF MANDAMUS

THIS CAUSE came before the Court upon Petitioner's Petition for Writ of Mandamus filed on June 3, 2021 (Petition). The Court, having reviewed the Petition and applicable statutory and caselaw, and being otherwise fully advised in the premises, finds and concludes as follows:

- The Petition stems from a residential eviction case filed in Lake County Court (case number 35-2021-CC-002055).
- This Court does not have original jurisdiction over residential eviction cases. See Art.
 V, § 5(b), Fla. Const.
- 3. This Court does not have appellate jurisdiction over residential eviction cases. See Ch. 2020-61, § 3 Laws of Fla. "A circuit court may issue an extraordinary writ only where it has original or appellate jurisdiction." Wovas v. Tousa Homes, Inc., 940 So. 2d 1166,1167 (Fla. 2d DCA 2006); see also Dep't of Health, Bd. of Dentistry v. Barr, 882 So. 2d 501, 501 (Fla. 1st DCA 2004) ("The circuit court does not have jurisdiction to issue an extraordinary writ if it does not have direct appellate jurisdiction over the subject matter.").

It is therefore ORDERED and ADJUDGED that Petitioner's Petition for Writ of Mandamus filed on June 3, 2021, is DISMISSED.
