

DISSOLUTION OF MARRIAGE WITH NO DEPENDENT OR MINOR CHILD(REN) OR PROPERTY

This checklist is designed to help persons seeking to represent themselves in court without the assistance of an attorney. It is meant to serve as a guide only. It is not guaranteed that either the instructions or the forms will achieve the result desired by the parties. It is not ensured that any individual judge will follow the procedures exactly or accept each form drafted. Any person using these instructions and forms does so at their own risk.

- **Petition for Dissolution of Marriage with No Dependent or Minor Child(ren) or Property**
Form 12.901(b)(3) Read all directions and complete the petition *entirely*.
- **Copy of Florida Driver's License or Florida Identification Card.** Must be issued at least 6 months prior to the date of filing. Alternatively, if your Florida Driver's License or Florida Identification Card does not meet the 6 month criteria, you must file the following:
 - **Affidavit of Corroborating Witness** - *Form 12.902(i)* **AND**
 - **Affidavit of Residency** (located on www.circuit5.org, under Self-Help, Lake County)
- **Cover Sheet for Family Court Cases** - *Form 12.928*
- **Notice of Related Cases** - *Form 12.900(h)*
- **Notice of Social Security Number** - *Form 12.902(J)*
- **Affidavit of Military Service** - *Form 12.912(b)*
- **Family Law Financial Affidavit**
 - Short Form - *Form 12.902(b)* If gross individual annual income is under \$50,000
 - Long Form - *Form 12.902(c)* If gross individual annual income is above \$50,000

Additional Forms: Certificate of Mandatory Disclosure – *Form 12.932*, Disclosure from Nonlawyer – *Form 12.900(a)*

SERVICE OF PROCESS IS REQUIRED ON THE RESPONDING PARTY UNLESS AN ANSWER (*FORM 12.903(a)* OR *12.903(b)* OR *12.903(c)(3)*) IS SIGNED BY THE RESPONDING PARTY AND FILED IN THE CASE.

Personal Service

- **Summons: Personal Service on an Individual** - *Form 12.910(a)*

Constructive Service

****MUST** attempt Personal Service at respondent's last known address **BEFORE** proceeding with this type of service**
This is a complicated area of the law and you may want to consult with an attorney before using constructive service.

- **Affidavit of Diligent Search and Inquiry**- *Form 12.913(b)* – Attach supporting documentation.
- **Notice of Action** - *Form 12.913(a)(1)* – Read instructions thoroughly.
