- **Stepparent Adoption: Consent of Adoptee** <u>Form 12.981(a)(2)</u> Must be completed if the adoptee is over 12 years old.
- **Stepparent Adoption: Consent and Waiver by Parent** <u>Form 12.981(a)(1)</u> Filed by natural parent whose parental rights are being terminated. If there is no agreement refer to Service of Process below.
- Motion for Search of the Putative Father Registry Form 12.981(a)(6) Pursuant to Florida Statute 63.054(7)(a) a search of the Putative Father Registry shall be done in ALL adoption cases, regardless of joint petitioner being the natural father. After the Court has signed the order granting the motion, a certified copy from the Clerk's Office must be obtained and mailed to Florida Department of Health, Bureau of Vital Statistics along with the application and fee to perform the search. - **Stepparent Adoption: Affidavit of Nonpaternity** <u>Form 12.981(a)(3)</u> Use of this form is **required only** when a stepfather is adopting his wife's minor child, **and** the mother and natural father were never married and paternity has **not** been established by a valid acknowledgement or court proceeding.
- Certified Copy of Adoptee(s) Birth Certificate(s)

- **<u>MUST</u> attempt Personal Service at respondent's last known address <u>BEFORE</u> proceeding with this type of service** This is a complicated area of the law and you may want to consult with an attorney before using constructive service.
 - Affidavit of Diligent Search <u>Form 12.913(c)</u> Attach all supporting documentation.
 - Notice of Action for Termination of Parental Rights and Stepparent Adoption <u>Form</u> 12.913(a)(3) Read instructions thoroughly. Publication is required.
