WHEREAS, the attached Probate Certification Checklists are intended to provide case filing guidance to litigants, to streamline the processing of cases, and to reduce the number of submission rejections; and

WHEREAS, it is deemed necessary and appropriate for the prompt, effective, and efficient administration of justice within

the Courts of Lake County, Florida; with the advice and consent of the Chief Judge of the Fifth Judicial Circuit and all Lake County Judges who handle probate cases;

It is **THEREFORE ORDERED** as follows:

- 1. All litigants must utilize the appropriate Certification Checklist(s) attached hereto.
- 2. All completed Certification Checklist(s) shall be submitted as supporting document(s) to any proposed orders in estate administrations.
- 3. Litigants must make all necessary election and fill-in all required sections of the applicable Certification Checklist(s). Any submissions without an accompanying Probate Certification Checklist may be rejected.
