Constructive Service

- **<u>MUST</u> attempt Personal Service at respondent's last known address <u>BEFORE</u> proceeding with this type of service** This is a complicated area of the law and you may want to consult with an attorney before using constructive service.
 - Affidavit of Diligent Search Form 12.913(c) Attach all supporting documentation.
 - Notice of Action for Termination of Parental Rights and Stepparent Adoption Form 12.913(a)(3) Read instructions thoroughly. Publication is required.
