## **DISSOLUTION OF MARRIAGE WITH DEPENDENT OR MINOR CHILD(REN)**

This checklist is designed to help persons seeking to represent themselves in court without the assistance of an attorney. It is meant to serve as a guide only. It is not guaranteed that either the instructions or the forms will achieve the result desired by the parties. It is not ensured that any individual judge accept each form drafted. Any person using these instructions and forms does so at their own risk.

Please note, the Family Court Case Management Self-Help Office provides procedural information and cannot give legal advice.

- **Petition** Form 12.901 (b)(1) Please read all directions and complete the petition in its entirety. Please pay particular attention to the following:
  - Petitioner or Respondent must have been a resident of Florida for 6 months prior to the date of filing
  - Date of marriage and date of separation
  - List of <u>all</u> child(ren) and birth dates (must be listed in paragraph 4 (b) or 4 (c), even those not common to both parties)
  - Marital assets and liabilities
  - Petition must be signed and notarized
- Coversheet for Family Court Cases <u>Form 12.928</u>
- Disclosure from Nonlawyer Form 12.900 (a)
- **UCCJEA Affidavit** <u>Form 12.902 (d)</u> MUST include child(ren)'s residence for last 5 years (or since birth if under age 5)
- Notice of Social Security Number <u>Form 12.902 (j)</u>
- Family Law Financial Affidavit BOTH PARTIES MUST FILE (choose only one based on annual income)
  - Short form 12.902 (b) annual income under \$50,000 or Long form 12.902 (c) annual income over \$50,000

If <u>both</u> parties agree to waive filing financials, both parties may <u>jointly</u> complete the following forms:

- Notice of Joint Verified Waiver of Filing Financial Affidavits <u>Form 12.902 (k)</u> (all criteria must be met) and
- Affidavit of Income for Child Support <u>Form 12.902 (I)</u> (all criteria must be met)
- Designation of Current Mailing and Email Address Form 12.915
- Certificate of Mandatory Disclosure Form 12.932
- Child Support Guidelines Worksheet <u>Form 12.902 (e)</u>
- Marital Settlement Agreement <u>Form 12.902 (f)(1)</u> If both parties agree, please complete the agreement in its entirety. <u>Must be signed and notarized by both parties (or proposed by Petitioner if parties are</u>

## NOT in agreement)

- Parenting Plan If both parties agree, please complete the agreement in its entirety. <u>Must be signed</u>
   and <u>notarized by both parties</u> (or proposed by Petitioner if parties are NOT in agreement) Please
   choose from the following:
  - Parenting Plan Form 12.995 (a)
  - Supervised/Safety-Focused Parenting Plan Form 12.995 (b)
  - Relocation/Long Distance Parenting Plan Form 12.995 (c)

Note: Section VII Time-Sharing Schedule - must be completed in its entirety

- Completion of DCF Approved Parent Education and Family Stabilization course for <u>BOTH</u> parties A list of approved classes may be found on <u>www.circuit5.org</u> CLASS SHOULD BE COMPLETE WITHIN 45 DAYS OF FILING
- Copy of driver's license or voter's registration card Driver's License/Voter Registration <u>MUST</u> be issued at least 6 months <u>PRIOR</u> to the date of filing, in the alternative, you may complete an Affidavit of Corroborating Witness <u>Form 12.902 (i)</u> if your license was recently renewed/issued.
- Certificate or Affidavit of Military Service Form 12.912 (a)/ Form 12.912 (b)
- Notice of Related Cases <u>Form 12.900 (h)</u>

## Service of Process on Responding Party

Personal Service - Personal service is required if the party's whereabouts are known.

- Summons: Personal Service on an Individual Form 12.910(a)
- Process Service Memorandum Form 12.910(b)

Alternatively, the Respondent may file an Answer to Petition and Waiver of Service of Process. Forms are available at <a href="https://www.circuit5.org">www.circuit5.org</a>

<u>Service by Publication or Posting</u> - You <u>must</u> attempt personal service at the Respondent's last known address before filing an affidavit of diligent search.

• Affidavit of Diligent Search - Form 12.913 (b)

NOTE: This affidavit must be filled out completely with supporting documentation attached to the affidavit.

- By Publication: Must publish once a week for four (4) consecutive weeks in a publication in the county of the Court [See Florida Statute 49.10 (1)(a)]. PETITIONER RESPONSIBLE FOR PUBLISHING IN NEWSPAPER
- By Posting: If the Petitioner is found indigent by the Clerk of Court CLERK WILL POST FOR PETITIONER

- Motion for Default and Default <u>Forms 12.922 (a and b)</u> Filed when more than twenty (20) days from service has passed and Responding party has NOT filed an Answer
- Motion to Set Final Hearing Forms are available at <a href="www.marioncountyclerk.org">www.marioncountyclerk.org</a>
