AVAILABLE RESOURCES FOR UNREPRESENTED LITIGANTS

The Code of Judicial Conduct prohibits a judicial officer from giving legal advice to an unrepresented litigant. There are some helpful resources available to unrepresented litigants. The Court does not recommend or guarantee any of the services mentioned below.

Florida Bar Lawyer Referral Service, for a \$25 fee you can obtain a brief consultation with a local lawyer who practices family law. At that time you can ask questions, talk about what papers you need to file, and get advice about how to proceed on your own should you choose to do so.
