- **Petition** <u>Form 12.901 (a)</u> Please read all directions and complete the petition in its entirety. Please pay particular attention to the following:
 - Petitioner or Respondent must have been a resident of Florida for 6 months prior to the date of filing
 - Date of marriage and date of separation
 - Division of Marital Assets and Liabilities (must check one on #6 of Petition)
 - Petition must be signed by both parties
- Coversheet for family Court Cases *Form 12.928*
- Disclosure from Nonlawyer Form 12.900 (a)
- Designation of Current Mailing and Email Address *Form 12.915*
- Notice of Social Security Number Form 12.902 (j)
- Family Law Financial Affidavit- Each party <u>must</u> file if they are not filing a Marital Settlement Agreement.
 - <u>Short form 12.902 (b) if gross individual annual income is under \$50,000 **OR** Long Form 12.902(c) If gross individual annual income is above \$50,000</u>
- Certificate of Mandatory Disclosure *Form 12.932*
- Marital Settlement Agreement <u>Form 12.902 (f)(3)</u> <u>Must be complete and signed and notarized by both</u> parties

OR

If <u>both</u> parties agree to waive filing financials, both parties may jointly complete the following form:

- Notice of Joint Verified Waiver of Filing Financial Affidavits *Form 12.902 (k)* (all criteria must be met)
- Copy of Driver's License or Voters Registration Card Driver's License/Voter Registration MUST be issued at least 6 months <u>PRIOR</u> to the date of filing, in the alternative, you may complete an Affidavit of Corroborating Witness <u>Form 12.902 (i)</u> if your license was recently renewed/issued.
- Notice of Related Cases Form 12.900 (h)
