 - Petition must be signed and notarized
- Disclosure from Nonlawyer Form 12.900 (a)
- UCCJEA Affidavit Form 12.902 (d) MUST include child(ren)'s residence for last five (5) years
- Notice of Social Security Number Form 12.902 (j)
- Family Law Financial Affidavit BOTH PARTIES MUST FILE (choose only one based on annual income)
 - <u>Short form 12.902 (b) annual income under \$50,000 or Long form 12.902 (c) annual income over</u> <u>\$50,000</u>

- If <u>both</u> parties agree to waive filing financials, both parties may <u>jointly</u> complete the following forms:
