**ADMINISTRATIVE ORDER REGARDING  
THE FIFTH JUDICIAL CIRCUIT BOND SCHEDULE**

**AND**

**VACATING AND REPLACING  
AMENDED ADMINISTRATIVE ORDER A-2014-12-B**

**WHEREAS**, persons arrested and charged with crimes or violations of municipal or county ordinances have a right to be released from jail custody on reasonable bond, if the offense is bondable and there are no circumstances adverse to release; and

**WHEREAS**, the Florida Legislature enacted section 903.011(5)(a), Florida Statutes, requiring the Florida Supreme Court to adopt a uniform statewide bond schedule that must be used by the police, county jail, or pretrial release employees upon a person's arrest; and

**WHEREAS**, The Supreme Court of Florida issued Administrative Order No. AOSC23-88 IN RE: UNIFORM STATEWIDE BOND SCHEDULE, on December 12, 2023, to be effective **January 1, 2024**; and,

**WHEREAS**, the uniform statewide bond schedule "**applies when the police or county jail or pretrial release employees exercise their discretion to release a person on bond before that person's first appearance hearing**", and "shall not bind a judge in an individual case who is conducting a first appearance hearing or bail determination[;]" and,

**WHEREAS**, according to section 903.011(6), Florida Statutes, the uniform statewide bond schedule applies to criminal offenses **except** for offenses that meet the following criteria:

(a) the person was, at the time of arrest for any felony, on pretrial release, probation, or community control in this state or another state;

(b) The person was at the time of arrest, designated as a sexual offender or sexual predator in this state or any other state;

(c) The person was arrested for violating a protective injunction;

(d) The person was, at the time of arrest, on release from supervision under sections 947.1405, 947.146, 947.149, or 944.4731, Florida Statutes.

(e) The person has, at any time before the current arrest, been sentenced pursuant to section 775.082(9) or section 775.084, Florida Statutes, as a prison releasee reoffender, habitual violent felony offender, three-time violent felony offender, or violent career criminal;

(f) The person has been arrested three or more times in the six (6) months immediately preceding his or her arrest for the current offense; or

(g) The person's current offense of arrest is for one or more of the following crimes:

(1) A capital felony, life felony, felony of the first degree, or felony of the second degree;

(2) A homicide under chapter 782; or any attempt, solicitation, or conspiracy to commit a homicide;

(3) Assault in furtherance of a riot or an aggravated riot; felony battery; domestic battery by strangulation; domestic violence, as defined in section 741.28, Florida Statutes; stalking; mob intimidation; assault or battery on a law enforcement officer; assault or battery on a juvenile probation officer, or other staff of a detention center or

commitment facility, or staff member of a commitment facility, or health services personnel; assault or battery on a person 65 years of age or older; robbery; carjacking; or resisting an officer with violence;

(4) Kidnapping, false imprisonment, human trafficking, or human smuggling;

(5) Possession of a firearm or ammunition by a felon, violent career criminal, or person subject to an injunction against committing acts of domestic violence, stalking, or cyberstalking.

(6) Sexual battery; indecent, lewd, or lascivious touching; exposure of sexual organs; incest; luring or enticing a child; or child pornography;

(7) Abuse, neglect, or exploitation of an elderly person or disabled adult;

(8) Child abuse or aggravated child abuse;

(9) Arson; riot, aggravated riot, inciting a riot, or aggravated inciting a riot; or burglary or theft during a riot;

(10) Escape; tampering or retaliating against a witness, victim, or informant; destruction of evidence; or tampering with a jury;

(11) Any offense committed for the purpose of benefitting, promoting, or furthering the interests of a criminal gang;

(12) Trafficking in a controlled substance, including conspiracy to engage in trafficking in a controlled substance;

(13) Racketeering; or

(14) Failure to appear at required court proceedings while on bail.

**WHEREAS**, AOSC23-88 provides that the Chief Judge may establish a local bond schedule that adds conditions of release and/or increases the bond amount above those required by the Uniform Statewide Bond Schedule; and,

**WHEREAS**, uniformity throughout the Fifth Judicial Circuit is an appropriate consideration when establishing the amount of bail for the same charge regardless of the county in which the offense occurs, the arrest is made, or the warrant is issued; and

**WHEREAS**, the Fifth Judicial Circuit Bond Schedule is intended as a reference to assist law enforcement to establish a bond amount in connection with arrest, if the arrestee is eligible for bond and not statutorily required to go to first appearance before a judge; and

In consideration thereof and in accordance with Florida Rule of General Practice and Judicial Administration 2.215 it is:

**ORDERED:**

1. The bond schedule below is effective in the Fifth Judicial Circuit from the date of this Order, through December 31, 2024, and must be used by the police, county jail, or pretrial release employees upon a person's arrest:

(1) For persons arrested for a crime listed in section 903.11(6), Florida Statutes or who meets the criteria in section 903.011(6), Florida Statutes:

Bond: None  
First appearance required

DBMJN

- (2) For persons not covered by number (1) and arrested for a **third degree felony** that involved any amount of force or threat of force against a person:

Bond: \$5,000

- (3) For persons not covered by number (1) and arrested for a **third degree felony** that did not involve force or threat of force against a person:

Bond: \$2,500

- (4) For persons not covered by number (1) and arrested for a **first degree misdemeanor or an ordinance punishable like a first degree misdemeanor** that involved any amount of force or threat of force against a person:

Bond: \$1,000

- (5) For persons not covered by number (1) and arrested for a **first degree misdemeanor or an ordinance punishable like a first degree misdemeanor** that did not involve force or threat of force against a person and that is not driving under the influence or boating under the influence:

Bond: \$500

- (6) For persons not covered by number (1) and arrested for a **second degree misdemeanor or an ordinance punishable like a second degree misdemeanor** that involve any amount of force or threat of force against a person:

Bond: \$250

- (7) For persons not covered by number (1) and arrested for a **second degree misdemeanor or an ordinance punishable like a second degree misdemeanor** that did not involve any force or threat of force against a person

and that is not driving under the influence or boating under the influence:

Bond: \$150

- (8) For persons not covered by numbers (1) or (3), arrested for **driving under the influence (316.193, Florida Statutes) or boating under the influence (327.35, Florida Statutes):**

- a. First degree misdemeanor.

Bond: \$2000

- b. Third offense outside of 10 years.

Bond: \$5000

- c. Second offense, second degree misdemeanor.

Bond: \$2000


- d. First offense, second degree misdemeanor.

Bond: \$1000

2. Pursuant to section 903.047(1)(a), Florida Statutes, and Florida Rule of Criminal Procedure 3.131(a), an arrested person released from jail before trial must refrain from criminal activity of any kind and must refrain from any contact of any type with the victim, except through pretrial discovery pursuant to the Florida Rules of Criminal Procedure. A violation of either of these conditions of pretrial release subjects the arrestee to revocation of bond.
3. Each crime of arrest requires a separate bond pursuant to section 903.02(4), Florida Statutes and Florida Rule of Criminal Procedure 3.131(b)(2).

4. Paragraph 1, Page 4, is supplemented by the attached enumerated non-exhaustive Bail Schedule, which shall be for the use of **the police or county jail or pretrial release employees exercising their discretion to release a person on bond before that person's first appearance hearing** within the Fifth Judicial Circuit when that person is not statutorily required to go to first appearance before a judge. At first appearance, Judges may set bond, the amount thereof, and other conditions of release as they deem appropriate in their discretion.
5. This Administrative Order is effective immediately.
6. In the event this Order, or any portion thereof, becomes in conflict with any provision of AOSC23-88, that portion of this Order is superseded to the extent needed for this Order to be in accordance with AOSC23-88 or any subsequent amendments thereof.
7. Amended Administrative Order A-2014-12-B is vacated, superseded, and replaced by this Order.
