- Petition for Dissolution of Marriage with Property But No Dependent or Minor Child(ren) <u>Form</u>
 12.901(b)(2) Please read all directions and <u>complete the petition in its entirety</u>. Please pay particular attention to the following:
 - Petitioner or Respondent must have been a resident of Florida for 6 months prior to the date of filing
 - Date of marriage and date of separation
 - · Marital assets and liabilities
 - Petition must be signed and notarized
- Copy of Florida Driver's License or Voter's Registration Card. Driver's License/Voter Registration MUST be
 issued at least 6 months PRIOR to the date of filing, in the alternative, you may complete an Affidavit of
 Corroborating Witness Form 12.902 (i) if your license was recently renewed/issued.
- Designation of Current Mailing and E-Mail Address <u>Form 12.915</u>
- Cover Sheet for Family Court Cases <u>Form 12.928</u>
- Notice of Related Cases <u>Form 12.900(h)</u>
- Disclosure From Nonlawyer Form 12.900(a)
- Certificate or Affidavit of Military Service Form 12.912 (a)/ Form 12.912 (b)
- Notice of Social Security Number <u>Form 12.902(j)</u>
- Family Law Financial Affidavit BOTH PARTIES MUST FILE (choose only one based on annual income)
 - Short Form 12.902(b) If gross individual annual income is under \$50,000 or Long Form 12.902(c) If gross individual annual income is above \$50,000

OR

If <u>both</u> parties agree to waive filing financials, both parties may <u>jointly</u> complete the following form:

- Notice of Joint Verified Waiver of Filing Financial Affidavits <u>Form 12.902 (k)</u> (all criteria must be met)
- Marital Settlement Agreement Form 12.902 (f)(2)

- If BOTH parties agree, please complete the agreement in its entirety. Must be signed by BOTH parties and notarized
- If parties DO NOT agree, Petitioner must complete a proposed marital settlement agreement for filing

Note: When filing a Marital Settlement Agreement, both parties are required to file a Financial Affidavit

Service of Process on Responding Party

<u>Personal Service</u> - Personal service is <u>required</u> if the party's whereabouts are known.

- Summons: Personal Service on an Individual <u>Form 12.910(a)</u>
- Process Service Memorandum <u>Form 12.910(b)</u>
 Alternatively, the Respondent may file an Answer to Petition and Waiver of Service of Process. Forms are available at www.circuit5.org

<u>Service by Publication or Posting</u> - You <u>must</u> attempt personal service at the Respondent's last known address before filing an affidavit of diligent search.

- Affidavit of Diligent Search <u>Form 12.913 (b)</u>
 NOTE: This affidavit must be filled out completely with supporting documentation attached to the affidavit.
 - By Publication: Must publish once a week for four (4) consecutive weeks in a
 publication in the county of the Court [See Florida Statute 49.10 (1)(a)]. PETITIONER
 RESPONSIBLE FOR PUBLISHING IN NEWSPAPER
 - By Posting: If the Petitioner is found indigent by the Clerk of Court CLERK WILL POST FOR PETITIONER
- Motion for Default and Default <u>Forms 12.922 (a and b)</u> Filed when more than twenty (20) days from service has passed and Responding party has NOT filed an Answer.
- Motion to Set Final Hearing Form available at www.marioncountyclerk.org
